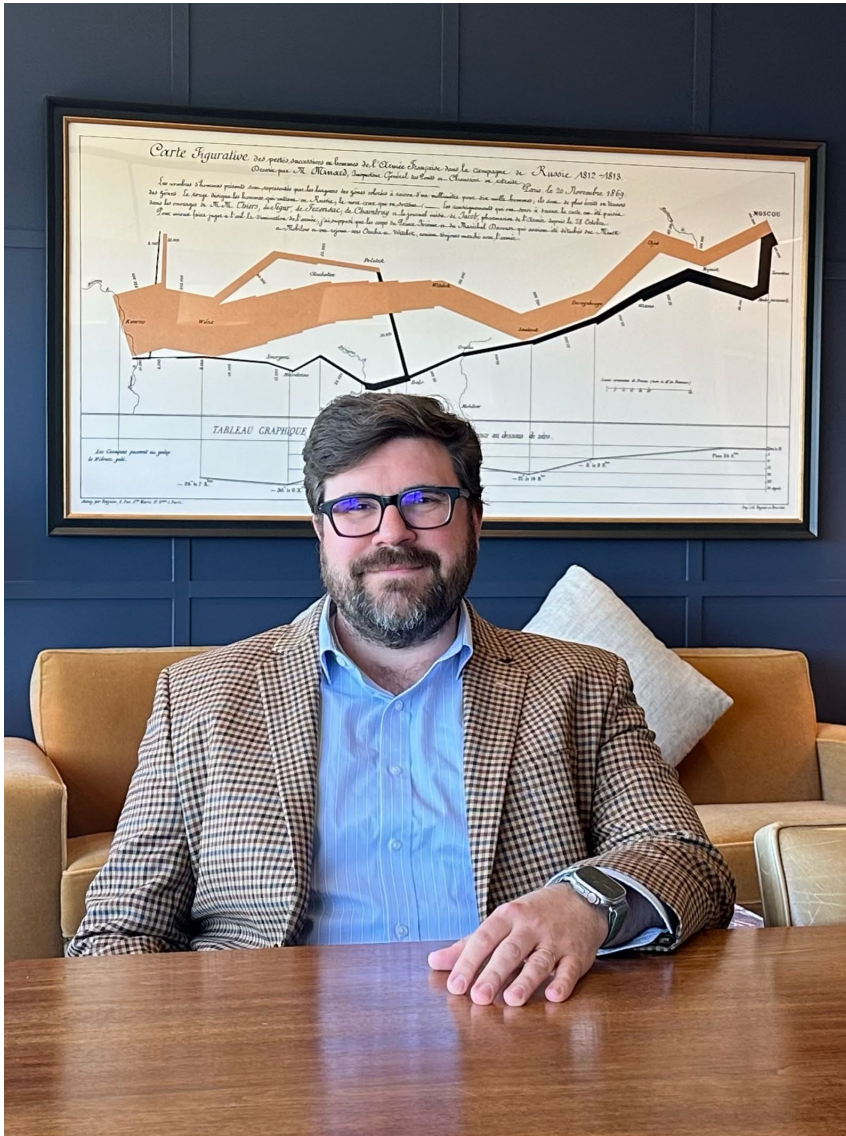


Greg Brown
