



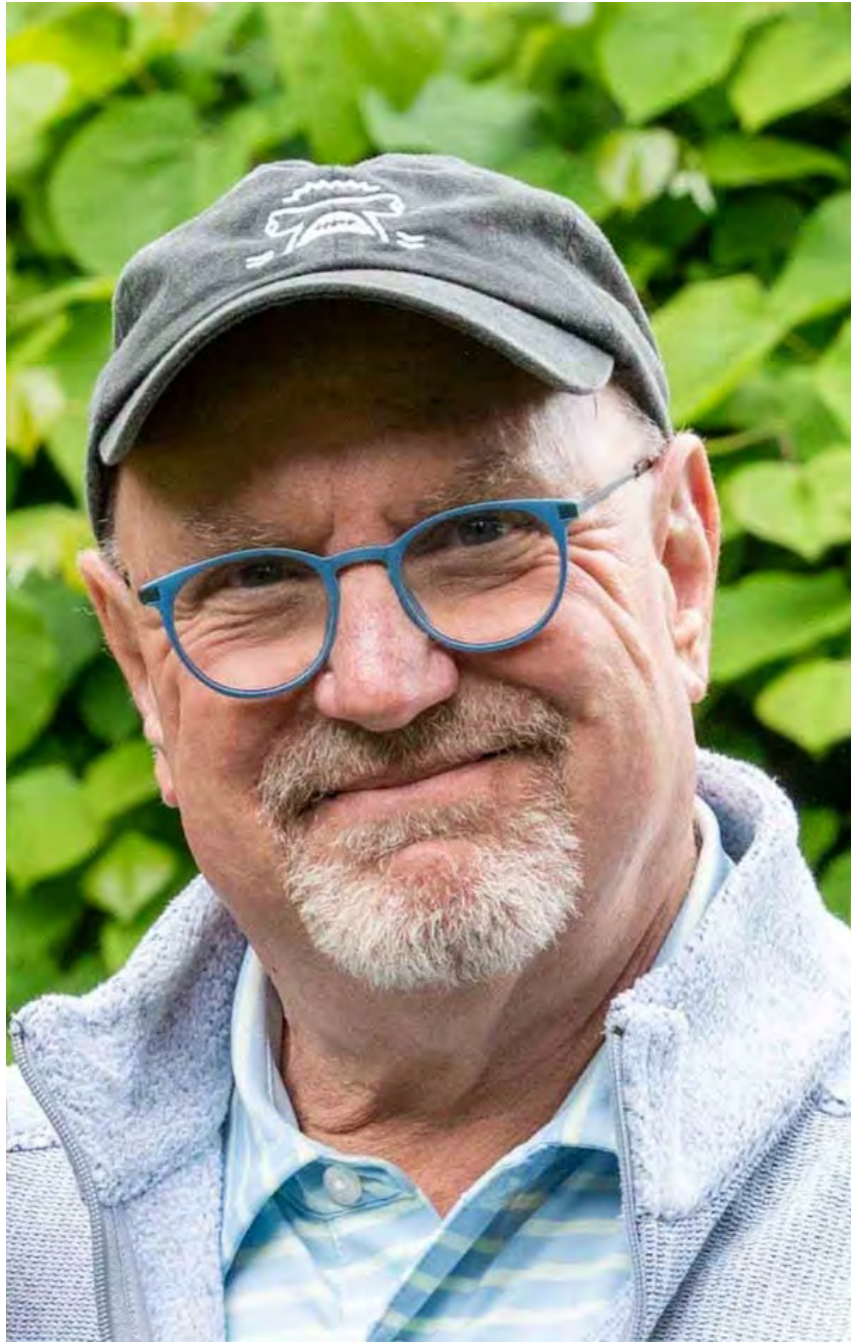
Taylor Bearden
